

# Town of Tamworth Facilities Permit Policy Transfer Station & Beach Facilities

# **Policy:**

A facility permit sticker is required for vehicles entering the Tamworth Transfer Station, Chocorua Lake Tamworth Resident Only Parking Area and Bearcamp Pond Beach Area.

# Per the Traffic and Road Regulation:

- 1.06 Prohibited Parking -Year-Round
  - **F**. No parking in any area marked as Residents Only, unless said vehicle is that of a resident or guest of a resident, and clearly has a current year Town permit sticker readily visible on their windshield.

#### **Procedure:**

The Town of Tamworth requires all property owners/renters, seasonal guest and/or campground recreational vehicles to display a facility sticker for use of the Tamworth Transfer Station, Chocorua Lake Resident Only Parking Area and Bearcamp Pond Beach Area .

Permits can be obtained from the Tamworth Town Clerk:

- 1. **All property owners/residents** must have a facility permit sticker by **April 30** every two (2) years. The Town Clerk will require proof of residency/property ownership.
- 2. **Renters:** Must provide either a notarized letter from the landlord's, a current signed lease/rental agreement along with a current utility bill showing your physical address in Tamworth.

<u>Tamworth Facility Sticker:</u> Facility stickers shall be placed in the lower right hand corner of the windshield on the passenger's side of the vehicle. The facility sticker must be displayed any time the Transfer Station, Chocorua Lake Tamworth Resident Only Parking Area or Bearcamp Pond Beach Area is being used.

**Facilities Permit Stickers:** May be obtained at the Tamworth Town Clerk Office or by Mail in application. (See attached)

One Replacement sticker will be given at no additional cost to those who can show proof of previous sticker (the old one, a portion of it, etc.) Without proof, the cost of the replacement sticker will be \$10.00 and reason must be given for why the original is no longer valid.

If trading in a vehicle/selling etc., it is best to try to peel the sticker or a portion of the sticker off the vehicle at that time in order to receive a replacement sticker at no charge.

Additional stickers, more than the two (2) given may be obtained at the cost of \$10.00 for a two(2) year sticker.

It is the property owners' responsibility to keep Facilities Permit Sticker for two (2) years for use.

## **Violations:**

<u>Any vehicle</u> using the Tamworth Transfer Station, Chocorua Lake Resident Parking Only area or Bearcamp Pond Beach Area that does not have a Tamworth Facility sticker displayed will have their license plate recorded and considered to be in violation of the Facility Sticker Policy. Violations will be subject to a written warnings and/or fines. Fines imposed will Fifty dollars (\$50.00) and will increase by \$50.00 for every subsequent violation. All fines shall be payable within fourteen (14) days to the Tamworth Police Department. If the fine is not paid within fourteen days, the fine amount will double.

Repeat offenders may be denied future access for use of the Tamworth Transfer Station, Chocorua Lake and/or Bearcamp Pond Beach Area.

**Appeal:** Appeal of an issuance of a parking violation fine may be made to the Board of Selectman or the Chief of Police. Failure to pay the fine shall result in the issuance of a summons to appear in District Court. Any person found guilty of violating the provisions of this ordinance shall be guilty of a violation and may be fined up to Five Hundred dollars (\$500).

## QUESTIONS AND/OR CLARIFICATIONS RELATED TO THIS POLICY

All questions and/or clarifications of this policy and its related content should be addressed to the Board of Selectmen, who shall be responsible for the administration, revision, interpretation, and application of this policy.

The Tamworth Board of Selectmen adopted this policy on the 18<sup>th</sup> day of May 2006; it was amended September 16, 2010, amended on December 1, 2011, amended on October 11, 2018 and amended on October 8, 2020.
