January 31, 2011

Meeting was called to order at 7:02 pm at the Town Office

The draft GPO has been reviewed by Atty Sager.. His advice indicates that it is ready to move forward. David Little made a motion to amend definition K to read "ENV-WS 272:14" and "ENV-WS 373:12". Becca seconded. APPROVED

Becca made a motion to put the GPO as amended on the warrant. Nicole seconded. APPROVED 5-0

David made a motion to adopt the Map version dated 1/12/11 as referenced in Article 3 as map referenced in ordinance. Becca seconded. APPROVED

In response to the Abolishment Hearing, a letter to the editor was drafted by Lianne, Skip, Dom and David. A discussion was held regarding edits to the letter. Melissa will make the corrections and email it to the Board.

Becca took Lianne's brochure and added photos and some capitalization. Dom would like to see a photo of the flag from the Brett School gym in the brochure. The committees will be deleted. Clerk name will be added. David would like to see some of the type changed to bold. Strike "regulation" from the Earth Excavation Committee. Under FORM - in the first paragraph, add "site visits". Edit to include that members "generally" sit on at least one sub-committee or serve as PB rep to....
