Board of Selectmen's Meeting  
October 30, 2008

- PRESENT:** William Farnum, John Roberts and Tom Abugelis
- OTHERS PRESENT:** Police Chief Daniel Poirier, Administrative Assistant Cassandra Pearce Road Agent Bruce Robinson, Parks & Rec Director Parker Roberts, and other members of the public.
- CALL TO ORDER:** *Chairman William Farnum called the meeting to order at 4:01 p.m*
- GREGGS WAY:** The Board met with Bill Jones from Gregg's Way (Gilman Tavern) to discuss the drainage problem. They recessed to walk Gregg's way to review. See if pipe issue can be fixed otherwise Mr. Jones will consider drainage easement. Road Agent will review the pipe on Friday and get measurements if pipe is not fixable.
- POLICE CHIEF:** Police Chief Poirier reported all was well. Been busy, finishing training, working on budget.
- ROAD AGENT:** Things are going well, met with FEMA gentlemen today to review from August rains. Plowing routes were distributed to the Board as well as a quote of sand sealing. Board would like to see the list of roads which need paving work by priority for this year as well for the next four years. They would like to get a contract for the paving prior to the end of this year. Requested that a list be done if possible of materials used on the roads, by road as they are being worked on. The Board would like to see a log for each truck, which includes what time, what material, on which road the work was done. The Board also requested Bruce put a list together for tools and equipment that will be needed for the new Highway Garage. The Board reviewed and discussed the plow routes; they would like to see the list of potential drivers for the Town vehicles. The Board also requested a list of part-time help that Bruce would propose to use for the winter.
- PARKS & REC** Parker informed the Board that Soccer and Flag football are winding down; he is meeting with Chris Canfield Sunday to discuss voting day and the set up.
- CHOCORUA PROJECT:** The Board discussed the status of the Chocorua Project. The Chocorua Community Association is meeting next Monday and

would like to be able to have a spot on the Agenda for next meeting.

**ADMINISTRATION:**

Motion made by William Farnum to cancel the meeting of 11/13 and 11/27. Motion seconded by John Roberts and passed unanimously.

Mr. Barnhart left a form for the Board to fill out for Residential Care in home. The Board signed off on the Health, Building and Zoning area. Mr. Barnhart will still need to see the Fire Chief.

Welfare Update: Motion made by William Farnum to replace Appendix A for the Welfare Guidelines with the updated Appendix A of October 30, 2008. Motion seconded by Tom Abugelis and passed unanimously.

The Board requested Ms. Pearce to draft a memo to the Road Agent regarding the request for paving.
