- 3. Review of the Department Budgets took place as follows:

- 1. Telephone Two cells phones and 3 land lines.
- 2. Salary One full time employee. Unable to determine increase as this has not been determined by the Selectmen.
- 3. Insurance buyout to remain the same.
- 4. Rescue/Training This line has been reduced by \$1000.00 from 2017.
- 5. Volunteer Incentive payout based on point system as adopted by Fire/rescue. Fire Department pays this once a year. Rescue pay two times a year.
- 6. Medical line this pays for DOT physicals and vaccines for staff and volunteers.
- 7. Equipment pays for medical supplies, turnout gear, medical oxygen and all other fire/rescue supplies.
- 8.Heating Fuel propane for four stations. *ABC recommends* decreasing this to \$12,000.00 as this is the highest paid in the last four years.
- 9. Water ABC recommends checking with Lakes Region Water to make sure the rates are not changing for 2018.
- 10. Office Supplies includes general supplies, Fire Safety supplies for Fire Safety week and Web hosting company fees.
- 11. Grants <u>ABC recommends</u> that the grant monies being considered be placed in expenditures so that they can be spent should the grant be received. That the warrant article stipulate that this money is only spent should the grant be obtained and non of this money is to be raised by taxes.

<u>ABC recommends</u> that Fire/Rescue/Emergency Management/ and Forestry Service all be placed in one Department and managed by one Department Head.
