▪ **SELECTMEN’S UPDATE:**

Selectman Goodson – attended Transfer Station meeting Monday. They are looking at a couple more grants. Dog Sled races are being held by the Outing Club on Sunday. They do not want attendees to bring their dogs.

Selectman Ricker – went to a Cemetery Meeting. He spoke to Alan and Glenn about the Transfer Station hours. He spoke with Richard Roberts about the Scott Road bridge project. Steel plank will be laid, it is shut down to one lane. He would like to purchase the materials next week. Work will be done in the spring.

Selectman Mason – Tuesday was the closing on the tax deeded property. Everything has been updated and done at the registry. Funds to previous owners will be determined. She attended a Planning Board meeting last night. They are working on some revisions to the regulations. Will it be mask optional at voting? We should have answers next week. For voting - the tables from the Town House are getting ruined moving them back and forth. Wrobleski Rentals - \$9 per table to rent, possible delivery fee. The election budget may need to be increased. Talk to Sharon about this.

Selectman Roberts – went through applications on Tuesday. He also carried in the Town Reports.

Chairman Mason – worked on the web page this week, delivered town reports and answered calls. Gail Marrone – we have submitted for the owl, she said it looked good. Water metering is being tested.

- PUBLIC INPUT: Pat Farley – could the Town have an angel fund, to help people with oil, etc. ? Welfare, Tri-CAP are in place. Taxes can be discussed. Remind people on the Exchange every so often? Selectman Goodson suggested that Pat contact the Tri County CAP for information. Send something about the Revolving Loan Fund, and we will add it to the website.  
Ed Comeau – regarding the voided check – the County has a voided check manifest. There was one in the past, it will be coming back.  
Lianne Prentice – Tamworth Foundation has set aside money for fuel assistance, etc. in the past.

Selectman Ricker suggested closing the office tomorrow due to snow. Selectman Streeter does not agree. Selectman Goodson made the motion to close tomorrow, Selectman Ricker seconded. Roll call vote: Goodson – yes, Ricker – no, Streeter – no, Roberts – no, Mason - yes. The office will be open.
