▪ **SELECTMEN'S UPDATE:**

- **Selectman Streeter:** Lightbulbs were sent out; Betsy from Historical Center wants to put a display in front of the Town House; attended Library meeting and Conservation meeting; did some filing; gave Roxy the DRA information on current use and exemption filing. WF mentioned that at the 2010 Town Meeting it was voted to remove ordinances. We should start looking into whether we can have a swim program this year. Karen to contact Jess Cullen and ask if she would attend a meeting to give an overview of what has been done in the past and if she had thoughts or ideas for future.
- **Selectman Goodson:** Finalized Rec committee. EDC meeting was rescheduled. Heard from a citizen that they are very happy that the Town House is open.
- **Selectman Mason:** SDS Program – FD not interested. Waiting to hear back from Highway. We should purchase for a month to enter in all information and print out; NH Promise Program; updating website; new water system in town at 425 White Mtn Hwy.
- **Selectman Farnum:** received a response back from Attorney on the Junkyard letter; Long term/Short term objectives for TS. Discussion ensued. Current contract ends Oct 31<sup>st</sup>. RFPs should go out by July with a decision made by September. Bruce Knox has designs ready. Willie and Glenn will meet with him. Becky and Willie to draft RFP. We should appoint a committee form TS long term/short term objective.

- **PUBLIC INPUT:** Linda Cook: Some people recycle on their own; Selectman Streeter asked about letting the public in the back door just to review maps. Discussion ensued.
