MEETING MINUTES

- **CALL TO ORDER:** called to order at 6:00 PM by Selectman Ricker. Present are: Selectman Mason, Selectman Melanie Streeter, Selectman Kelly Goodson, Selectman Aaron Ricker, Selectman Roberts, Town Administrator Karen Anthony, Richard Roberts, Ed Comeau – Government Oversight, Linda Cook, Kent Hemingway. On zoom: Jim and Maureen Diamond and Joe Haas.

Selectman Ricker nominates Selectman Mason as Chairman, seconded by Selectman Streeter. Selectman Mason nominates Selectman Ricker as Chairman. No second. Roll call vote for Selectman Mason as Chairman, Streeter – yes, Ricker – yes, Goodson – yes, Roberts – yes, Mason – abstains.

Selectman Mason motioned to indemnify the Board of Selectmen under RSA 31:104, RSA 31:105, and RSA 31:106, seconded by Selectman Goodson. Roll call vote: Streeter – yes, Roberts – yes, Ricker – yes, Goodson – yes, Mason – yes.

- **PUBLIC INPUT:** Jim and Maureen Diamond say Hi to Becky; Kent Hemingway asked if the tennis courts were listed on the agenda.
- **NEW BUSINESS:**
 - Richard Roberts, Road Agent: Received a quote from Allstate Construction for chip sealing parts of Old Mail Rd and Turkey Street for \$49,759.85. *Motion to accept the quote from Allstate Construction by Selectman Mason, seconded by Selectman Goodson. Roll call vote: Streeter – yes, Roberts – yes, Ricker – yes, Goodson – yes, Mason – yes;* Line striping in the village, parking lot, and cross walks in Chocorua; Receiving paving quotes; Did dust control on Washington Hill Road; Selectman Streeter asked about the fire truck. It is at Advanced Diesel and gets work done as money is available; TA Karen asked about ground maintenance equipment for CIP.
