**MEETING MINUTES**

- **CALL TO ORDER:** called to order at 5:30 PM by Selectman Mason. Present are: Selectman Mason, Selectman Streeter, Selectman Goodson, Town Administrator Karen Anthony, Ed Comeau – Government Oversight, Kim Trammell, and Linda Cook. On zoom: Selectman Roberts and Jim and Maureen Diamond.

Motion to enter into non-public under RSA 91-A:3 II (a) by Selectman Mason, seconded by Selectman Goodson. Roll call vote: Streeter – yes, Roberts - yes, Goodson – yes, Mason – yes

Motion to leave non-public session at 7:00 PM by Selectman Mason. Minutes will not be sealed. Seconded by Selectman Goodson. Roll call vote: Streeter – yes, Goodson – yes, Mason – yes.

- **NEW BUSINESS:**
  - Town Clerk/Tax Collector Kim Trammel update: Facility permit policy is working however there are issues with rental units. Would it better to go back to paper passes for the rental units rather than a 2 year sticker? Discussion ensued. Owners can place the sticker on plastic or laminate them and display them in the window. Campgrounds have amenities therefore they do not get free facility permit stickers. Dog licensing is good. All but \$375,052 have been collected from the tax warrant of \$4,484,676. Will give list of properties to be deeded in August for your review. All should be collectible.
  - Administrator Update: Bank balance is \$4,102,751 includes AP. About half will be paid to the school before next tax bill comes out; Project with NE Solar Garden has ended. *Motion to table the recreation fields being used for anything but recreational purposes by Selectman Mason, seconded by Selectman Goodson. Roll call vote: Streeter – yes, Goodson – yes, Mason – yes.* Kelly mentioned that the Town is still willing to install a solar field if we find a spot and residents can reach out to Mike if they want to install one; I'm attending a webinar with NHMA on the Right to Know and Public Meetings on Tuesday, July 20<sup>th</sup> from 12-1 if anyone wants to join me; Letter are going out tomorrow to the residents on Brewster Hill Rd. A public hearing on a road name change will be held on August 19<sup>th</sup> at 6 PM; We have 2 applicants for the part-time position at the Transfer Station. I will set up interviews for next week at 5:30; Budget season is fast approaching. I will advertise for volunteers for a budget committee; We received a hearing notice from BTLA. The resident is asking for you to agree for him to attend by telephone. *Motion to request him to be present by Selectman Mason, Selectman Streeter seconded. Roll call vote: Streeter – yes, Goodson – yes, Mason – yes.*

Karen emailed with answer to the question on who owns the speed bumps. She is receiving conflicting information of that. Still looking for a breakout of employee costs. Karen is working on it.

Becky thanks Emery for chairing last week's meeting. Becky appoints Emery to chair the first 2 meetings in August. Thank you to everyone who helped with the fireworks show. We are already working on setting a date for next year.
