- **New Business:**
- Nelson O'Bryan-Tamworth Conservation Commission/Perkins Easement – an overview was given. The conservation deed has a no subdivision clause in it. The State feels that one owner has to have all the property under the easement deed. Lianne Prentice elected to submit a proposed amendment to the deed. Additional property could be put under easement as a mitigation. The State would like to know if the Town supports this amendment. Chairman Mason is hesitant to support anything until the State has issued their decision. When the properties were sold, they were sold with quit claim deeds. Nelson can request that Christine contact the Attorney General's office to see what will happen if the Town does not support this. Selectman Goodson would have liked the homework to have been done beforehand. If this is going to be a conservation deed, the Conservation Commission has a template for that. Nelson will check with Christine to see how she feels about a solution for this. Nelson will email the office with her recommendations. A memo should be written by the Selectmen once a decision is made.
