**DRAFT MEETING MINUTES**

**CALL TO ORDER:** The meeting was called to order at 6:14 pm by Selectman Farnum. Present are: Selectman Willie Farnum, Selectman Melanie Streeter, Selectman Aaron Ricker, Selectman Kelly Goodson, Town Administrator Karen Anthony, and Linda Cook. On Zoom are Selectman Becky Mason and Chris Canfield.

• **NEW BUSINESS:**

- **Town Meeting Discussion:** Chris Canfield provided a proposal for a virtual Town Meeting, draft timeline, and NHMA timeline. Chris doesn't think we should have an in person Town Meeting. This would provide an alternative ballot for the voters on March 9<sup>th</sup> rather than voting at Town Meeting. If the BOS overrides the decision to have a virtual meeting, Chris will not be there to lead the meeting. Becky and Melanie are concerned about the individuals who either don't have internet access, don't have computers, and who may not know how to use the technology. Chris mentioned there are thoughts of setting up smaller satellite locations ie: library, school, townhouse in which residents can go and view the virtual meeting in a more covid safe environment. Willie is concerned that if the meeting is held in person many will not come because of Covid spread concerns. Aaron feels we should postpone the meeting until a later date. After a lengthy discussion, Chris will be contacting the Assistant Secretary of State and asking if we can have the virtual session before the February 2<sup>nd</sup> deadline for petitioned warrants? ; Are we able to have satellite locations during Town Meeting with an Assistant Moderator at each location? ; If postponing Town Meeting, do you postpone the election of officers? If yes, do we postpone the candidate file declarations? Kim will contact DRA and ask about the warrant articles if the budget has to revert back last years.
