DEPARTMENT HEADS:	Chairman Gray called the meeting to order at 4:06 p.m.
	Chairman Gray reported that the road agent, Richard Roberts has been involved with the G.W. Brooks bid regarding the Whittier Road Bridge project. Selectman Roberts reported the presence of a possible tire dump on Rte. 113.
	Police Chief Daniel Poirier discussed an inquiry from the Historical Society regarding serving liquor on the Green. Since it is private property it would be allowed.
	Pat Farley reported that the Tamworth Economic Development Commission has been working on a Forum that will take place in the fall to bring together companies and craftspeople in the region who will be willing to have an intern and/or an apprentice with those individuals interested in participating in such a program. The Commission is also working on plans for a 250 th celebration street fair for Tamworth featuring the businesses in Tamworth and will be held on a Saturday in August of 2016.
250 TH ANNIVERSARY:	Selectman Hidden discussed the restructuring of the group and spoke of the fundraising yard sale to be held at Runnell's Hall at 9am Saturday.
BARNSTORMERS:	Lou DeMaio requested a letter of approval from the Selectmen to the NH Liquor commission regarding the indoor sale of beer and wine at the Barnstormer's theatre during intermission. The board agreed to provide a letter. A request was also made to sell wine and beer outdoors; the board will inquire with town counsel to any possible liability for the town.
ADMINISTRATION:	Executive Assistant Darlene McWhirter reviewed and discussed the following items:

The BTLA hearing re. utility valuation 2010-2014 will occur on June 22 and will be attended by Selectmen Hidden and Roberts.

The posts for the "Welcome to Tamworth" signs will be dealt with by Richard Roberts.

There was a request from CIP asking that the Selectmen state their long-term monetary needs. Discussion ensued re. the appropriate amount for the study/implementation of town office reconfiguration. Peg Loughran offered to assist in contacting the architect who had previously presented plans.

Chocorua Village curb damage was discussed and Selectman Roberts suggested the Board meet to assess the damage. The board will walk the area on June 4^{th} .

As to an inquiry regarding the ability of the town to accept a monetary gift bequeathed in a will, the answer was in the affirmative.
