Chairman Gray called the regular portion of the meeting to order at 4:02

DEPARTMENT HEADS:

Road Agent Richard Roberts reported new grader is in use and has been lettered and would like board to look at it. They screened sand during rain, and replaced a number of culverts. The orange flags around belong to Asplundh Tree.

Pat Farley stated the EDC had a meeting on Tuesday to catch up on items. There was discussion on the forum in January, discussion on the banner to see about cost for street fair for the 250th. Talked about Tamworth Village Septic plans and about whether they would need an upgrade if new business was brought to the village.

David Farley updated the Board regarding the LRPC – Byways and the proposed new updated route.

The Board had received copies of the PD stats for July although Chief Poirier was unable to attend.

Recreation Director Parker Roberts is getting ready for the fall and did change battery in the defibrillator today. Board asked for an update on the fields. Stumps need to be hauled, but they have someone lined up to haul them off.

Bruno gave an update on the 250th Committee and stated there is a meeting coming up this Tuesday. The kick off event is still scheduled for 10/18/15 at the Remick Farm Museum.

FARMERS MARKET:

Bob Streeter stated the Farmers Market wanted to start out by stating it is grateful to David Little for the hard work and survey material, and also to the volunteers who did the counting. The Selectmen were given copies of the survey in advance of this meeting for review. The Board was asked if they had questions. Selectmen Gray had questions regarding some of the terms used and feels his concern is still Tamworth Road. The Board discussed posting signs on the opposite side of the Road. Selectmen Roberts stated originally this issue was brought up by the Selectmen as a safety issue because of the parking and safety at the intersection. But he feels now they are asking for the Board to support the State posting one side of 113 as no parking and he does not feel that would be fair to the property owner if they use it since the farmers market is only on Saturdays. After some discussion the Board, Bob Streeter & Peg Loughran agreed that the "Farmers Market" would do a trial of posting No parking signs on 113. One handicap parking sign on K. Brett tree is allowed in that one spot and they must contact the Police Department regarding modifications to the parking on Main Street. Additional they are to develop satellite parking sites. The Farmers Market will be on the agenda again on September 10, at 4:30.

PUBLIC COMMENT:

FLOODPLAIN:

Cy Rouleau had made an appointment to meet with the Board to discuss a parcel of property he was interested in purchasing. His concern is that it is noted to be in a floodplain even thou he has had been unofficially told it should not be categorized as such. The Board explained that the Town does not determine the floodplain areas and that he could apply to FEMA to have the lot removed and he was given an application to do so. He was also given the information needed to review the requirements of building in a floodplain area.

SELECTMEN UPDATES:

Selectmen Hidden stated there will be a meeting this coming Tuesday of the 250th Committee and he will discuss with them the handling of the revenues, expenses, and administration of funds.

Selectmen Gray stated initially he wanted to talk about the public computer again, but decided he wants to put the discussion off for another time so that he can look into additional items. There were questions as to why from the public and he stated the cost involved to upload programs to new sites, temp site until construction is decided on and other costs.

- Floodplain proposed changes: Packets are together for Planning Board and Selectmen's rep will present at next Planning Board meeting so that they may hold a Public Hearing on the changes.
- Dorothy Solomon is looking for a letter of Support to start a transitional housing facility for homeless veterans and should be able to use the two wings of the old county nursing home addressed to the County Delegation. The Selectmen would like to respond to her email with "Unfortunately the Board is of mixed opinions at this time and are unable to write a letter at this time. However, we do as a Board support your efforts on behalf of the veterans."
- Jonathan Bailey letter regarding volunteering with websites for non profits the Board is not interested at this time.
