#### BRIEF DESCRIPTION OF THE SUBJECT MATTER DISCUSSED AND FINAL DECISIONS:

Chairman Hidden explained to Sergeant Cooper the request from the committee to extend his probation. The board agreed that the situation that Sergeant Cooper was hired in was not a good one and that this request was to wait for the committee recommendations. Any shortcomings have been addressed and dealt with. Selectman Poirier made a motion to extend Sergeant Cooper's probation to June 24, 2017. The motion was seconded by Selectman Gray and passed (2-1).

Minutes and decisions reached in nonpublic session shall be publicly disclosed within 72 hours of the meeting, unless, by recorded vote of 2/3 of the members present, it is determined that the divulgence of the information likely would affect adversely the reputation of any person other than a member of the Board, or render the proposed action ineffective. In the event of such circumstances, information may be withheld until, in the opinion of a majority of the members, the aforesaid circumstances no longer apply.
