Tamworth Board of Selectmen 2012 Town Report

2012 proved to be demanding as always to all of us in Tamworth.

The Selectmen's responsibility is to use our best judgment in managing our Town's Government and spending everyone's tax dollars appropriately. It is our job to work with the people that you elect and to oversee the money that our town's people appropriate.

The Town saw a minimal .53 cent impact in the tax rate set for 2012. The Board used \$492,000 of undesignated fund balance to offset roughly a \$1.50 tax rate increase.

The Selectmen reviewed health insurance options for the employees and discussed cost of living pay increases for 2013. The majority of the Board does not support COLA increases for 2013 and elected to keep the insurance plan the same for another year despite a 5% increase in premiums.

The Highway Department welcomed its newest full time employee to increase the department's force to four full time workers. The crew has done an abundant amount of work including the rebuilding of the notorious Cleveland Hill, partial paving of Turkey Street and reconstruction of Mason Hill Road. The Department hopes to expand its fleet in 2013 with a new pickup truck and sand screener. These capital purchases will save the Town money by reducing the need for hired equipment.

The Board's hope of getting underway with Phase II of the Chocorua Project were shattered by the State imposed studies that have created numerous delays. We hope to see evidence of work in 2013.

The Board appointed Mariette Ross the Town Treasurer and wants to thank her for doing a great job. The Board would also like to thank all Town employees, Boards, Committee members, and volunteers that have worked diligently supporting our Town.

The Town mourned the loss of our oldest resident Harry Thompson and we would like pay our respects to everyone that has lost a loved one this past year.

In 2013 at the recommendation of the Economic Development Commission, the Town plans to install a webcam on top of the Great Hill Fire Tower. The camera will be accessible to the public through our website and will be controlled by the Fire Department for potential fire observation. Please stay tuned to our web site for continuing updates.

The Board encourages everyone with questions, comments, concerns, or suggestions to meet with the Board or feel free to call or write the Town Office.

You are hereby notified to meet for the First Session of the Annual Town Meeting at the Tamworth Town House, 27 Cleveland Hill Road, in said Town of Tamworth on <u>Tuesday</u>, the <u>12th of March</u>, 2013, to choose town officers and to vote on other matters required to be on the official ballot, polls to be open for voting on Articles 1 - 4 at ten o'clock in the forenoon, and to close not earlier than 7:00 o'clock in the evening, and you are hereby notified to meet for the Second Session of the Annual Town Meeting at the Kenneth A. Brett School, 881 Tamworth Road, in said Town of Tamworth on <u>Wednesday</u>, the 13th of March, 2013, at 7:00 o'clock in the evening for the transaction of all other Town business as specified in the remaining articles of this warrant.

Permitted Uses within the Wetlands Conservation District" as follows:

4. Notwithstanding any provision of this Ordinance to the contrary, no Special Use Permit or other Planning Board approval shall be required for any use for which a permit has been obtained from the New Hampshire Department of Environmental Services pursuant to RSA 482-A or the United States Army Corps of Engineers pursuant to 33 U.S.C. §1251 et seq.

Subsection 2 of "Section F. Special Provisions" shall be deleted in its entirety. (Majority Vote Required)

TREASURER'S REPORT

2012 was a year of change for the office of the Treasurer. First was Mary's resignation, after

All funds under the jurisdiction of the Treasurer's office were invested so the Town would

receive the maximum interest available at the time of the investment. Safety and liquidity is

primary consideration. Our primary investment entities offered safety through full

collateralization above FDIC amounts.

Investment interest in 2012 was less than 2011 a total of \$1,209.27 in 2012 and \$1,354.28 in

2011. The highest rate in 2012 was .21% for the accounts transferred from the Municipal

Deposit Investment Pool to Meredith Village Savings Bank.

Officer Anne Abear. Also, Cassandra Pearce, Kim Trammell, Elizabeth Hauser and the staff

Town Clerk/Tax Collector 2012 Annual Report

I would first like to thank all those who continue to support me as an elected official, because without your support I would not be here!! As I enter my third term on a very busy Presidential Election year, I again find that keeping the office educated through the various conferences, workshops, and annual meetings offered for both Town Clerk and Tax Collectors is beneficial for all. As mentioned last year, I was able to complete the Joint Certification Program as a Tax Collector, and in Oct. 2012 became a Certified Town Clerk as well. The following are the workshops and conferences attended this year:

April 10th - New Hampshire Tax Collectors Spring Workshop
June 15th - NH City & Town Clerks Regional Conference

August 13th-17th - NH Town Clerks/Tax Collectors Joint Certification Program

August 28th - Election Law Training - Legislative Changes/New Voter ID Law

September 17-19th - NH Tax Collectors Assoc. Annual Conference

Sept 26th & 27th - Motor Vehicle Advanced Training (Clerk & Deputy)

October 17- 19th - NH City & Town Clerks Assoc. Annual Conference

It is with great enthusiasm that the Town Clerk/Tax Collector's Office announces the completion of our 2012 goal of implementing the dog licensing and property tax services on-line. With that said, the office now provides the processing of vital record requests, dog licensing renewals, motor vehicle registration renewals, and property tax payments all on-line. The methods of payments accepted on-line are ACH and Credit Cards (MasterCard, Visa, & Discover). A 2.95% convenience fee is charged to the customer using the credit card option. In recapping the years past and the steps necessary to bring the on-line services to light, we began in August 2008 with the "State portion" processing of motor vehicle registrations and the new revenue generated from the municipal agent fee, in October 2009 the "single payment" one-check method approved by the State of NH became possible, and by doing so in April 2011 the credit card option became available both over the counter and on-line. We began the on-line services in January 2010 with motor vehicle registrations, March 2011 we added the vital records request service, January 2012 dog licensing, and in July 2012 property tax payments. Residents may access all of these on-line services from the home page of the Town of Tamworth's website located at www.tamworthnh.org. By implementing these services it has enabled our office to maintain the efficiency necessary in keeping costs down in the operations of everyday business, which is a win-win for all. This year 680 dogs were licensed, and again we would like to remind residents that it is necessary to license dogs by April 30th each year to avoid penalties.

In closing, I'd like to say thank you to all of the truly dedicated election officials who so conscientiously helped to implement the Voter ID legislative changes that were requested for the State Primary Election, and required for the General Election. TRUSTEES OF CEMETERIES & TRUST FUNDS

2012 REPORT

In March, the Town voted for members of the two separate boards – Trustees of Trust Funds and Trustees of Cemeteries – replacing the past practice of considering the Trustees of Trust Funds as Trustees of Cemeteries as well. Mark Albee, John Roberts and John Wheeler were elected Cemetery Trustees and Alex Cook and John Wheeler remained as Trust Fund Trustees. A vacant position on the latter board was filled by the Selectmen's appointment of Willie Farnum. The members agreed to hold joint meetings as much as possible. Alex Cook decided to not attend meetings.

TRUST FUNDS:

As Trustees of Trust Funds, we are currently responsible for the safekeeping and investment of approximately \$647,007 in trust and reserve funds. The details of these funds are shown on the accompanying schedules. As of December 31, 2012, we were holding \$437,617 for the cemeteries, library, and school. In addition, we were holding \$207,982 in other capital reserves. These are non-permanent funds established for such Town purposes as making bridge repairs and permanent funds for specific purposes such as park maintenance, and rescue squad equipment. In accordance with Town Meeting votes and as recommended by the Capital Improvement Plan Committee and Selectmen, most reserve funds have been closed and the funds transferred to the general fund. The transportation enhancement capital reserve fund was closed in 2012 as indicated with an X in the date created column.

Cemetery funds are invested with Northway Bank. The rest of funds are invested in the NH Public Deposit Investment Pool. Due to the low interest rates available to everyone, we earned only \$1759 in interest for the year. Please see the following report for the details of the accounts.

CEMETERIES:

With two new cemetery trustees elected in the spring, early meetings were devoted to visiting most of the town cemeteries to assess their condition and needs. There are sixteen graveyards that receive maintenance on a regular basis: these fall into two groups based on their activity for new burials and the degree of seasonal care they have scheduled.

The first group includes the major cemeteries; Wonalancet, Fowlers Mill, Chocorua, Riverside and Ordination Rock. Burial and cremation plots are available. Seasonal care includes spring and fall clean-ups, brush and debris removal, frequent mowing and trimming through the growing season, and the placement of flags on veterans graves prior to Memorial Day. In addition, the Veterans Memorial in the village gets regular mowing and trimming and annual flowers each spring.

The second group includes eleven cemeteries in which no new plots are available. These include Smith, Meader, Stevenson, Bickford-Moulton, Pease, Chapman, Head/Neally, Gilman, Great Hill, Ames and Hainert. These tend to be small in size, on rough, marginal land surrounded by woodlands and often more difficult to access. Some are owned by the Town. Others are privately owned or we have not determined the ownership. Spring and fall cleanups, less frequent mowing and trimming characterize their care. More costly, in time and money, can be the unanticipated tree falls and associated cleanup.

In all cemeteries, more long term investment to maintain infrastructure is needed. This October a step was taken to address the need for restoration of gravestones with a volunteer day led by Jessica Felix of Freedom. Twelve volunteers spent a full morning in the original section of Ordination Rock Cemetery working to set fallen stones aright, level and plumb leaning stones, and clean lichen and moss that obscure inscriptions. About 25 stones were worked on. We are grateful to Jessica for teaching these basic techniques and will continue to employ them at future volunteer days.

The Town Pound Fence at Ordination Rock has collapsed. We are working on replacing it with the assistance of donations and volunteers.

We have just purchased computer software that will be used to input information on each cemetery lot in the active cemeteries as to which are sold, unsold, have markers, and other information that is presently in various records. This will be an ongoing project that will take many volunteer hours. In preparation for this, we have had surveying work done at the Chocorua, Ordination Rock and Wonalancet cemeteries to insure lots are accurately located.

The Cemetery Trustees are grateful for the good work of the contractors maintaining the cemeteries, the cooperation and help of the Cook Memorial Library Staff and the Historical Society volunteers who are so knowledgeable about the records, and to all others who have helped us learn more about our duties and responsibilities. Thank you.

Capital Improvement Program Committee Report

Fiscal Years 2013-2018

The Capital Improvement Program (CIP) is a valuable part of town planning and budgeting.

The CIP report includes anticipated expenditures and funding for capital projects for the next 6 years, suggested warrant articles, tax rate effects, and descriptions of projects for voters and Selectmen. It is non-binding, advisory, and updated annually. Inclusion of projects and finances in the Report does not commit the Town to funding or expenditures. Projects are categorized and prioritized by need and urgency and reviewed annually.

The CIP Committee is required to report to the Planning Board and the Selectmen annually.

Over the last 2 years, the voters have discontinued most of the Town's capital reserve funds in order to eliminate the inflation-caused erosion of such funds and reduce taxes. Planning, budgeting, and cooperation by the departments, committees, boards, and commissions that provide services and maintain Tamworth's capital assets have resulted in a schedule which will meet the needs of the Town without continuing the reserve funds.

The CIP Report includes numerous examples of the departments' efforts to reduce costs, postpone replacements, and carefully plan ahead, resulting in lowering costs while maintaining services and protecting the Town's capital investments in troubled economic times.

The following two pages summarize the capital equipment and project plans. The full report includes additional information about the scheduled program, some definitions, goals, graphics, financial and tax rate information for Tamworth's taxpayers, residents, property owners, and businesses.

The Committee thanks the Town Departments, Boards, Committees, and Commissions for their cooperation, planning and budgeting on behalf of the Town and its taxpayers, and their assistance and patience in updating the CIP Report with us. As noted in the full report, the Committee is especially grateful for the assistance of Cassandra Pearce and Anne Abear.

NOTICE

If you own real estate lots that were involuntarily merged by municipal action, you may be able to have those lots restored to their pre-merger status.

Your property may qualify if two or more lots were merged for zoning, assessing, or taxation purposes and the merger occurred:

- During your ownership, without your consent; or
- Prior to your ownership, if no previous owner consented to the merger.

To restore your property to pre-merger status, you must:

- Make a request to the local governing body (Selectmen)
- No later than December 31, 2016.

Once restored:

• Your properties will once again become separate lots; however, they must still conform to applicable land use ordinances. Restoration does not cure non-conformity.

This notice must be:

- Posted continuously in a public place from January 1, 2012 until December 31, 2016, and
- Published in the 2011 through 2015 Annual Report.

Read the full statute at RSA 674:39-aa Restoration of Involuntarily Merged Lots.

2012 Annual Report for the Zoning Board of Adjustment

The Tamworth Zoning Board of Adjustment is empowered by NH RSA 674:33 to hear appeals to any administrative decisions on town regulations adopted pursuant to NH RSA 674:16. In addition, the ZBA is empowered to grant variances and special exceptions where it is specifically allowed in the regulation. The members of the ZBA are appointed by the Board of Selectmen.

In 2012, ZBA board member Tom Daley stepped down after many years of dedicated service. The Selectmen appointed alternate Peg Huddleston to fill the vacant position. The full Board roster consists of John Mersfelder, Chair; George Plender, Vice Chair; Lianne Prentice, Clerk; Harry Miller, Member; Peg Huddleston, Member; Tom Cleveland, Alternate; Dave Farley, Alternate; and Dan Rowe, Alternate. Chris Conrod serves as ZBA Secretary.

The ZBA currently meets quarterly for regularly scheduled meetings, on the second Tuesday in the months of January, April, July and October. During 2012, much of the time at these meetings was devoted to reviewing the special exception and appeal process, and revising the Rules of Procedure.

During the year, the ZBA acted on one application for Special Exception and three Administrative Appeals, all related to a proposed personal wireless service facility (PWSF, which is a cell-phone tower). In all cases, the ZBA found in favor of the applicants, Florida Tower Partners and New Cingular Wireless (ATT). Having ruled on the PWSF application, the ZBA acquired the legal status of administrative officer, and as such it monitored and guided the building permit process. A second application for Special Exception for a revised site plan was received from the applicants. The application was withdrawn by the applicants after correspondence with the ZBA.

ZBA Rules of Procedure and all application forms are available for download from the town website. Meeting and hearing minutes, as well as case files, are available for inspection at the Town Office.

It was another productive year for the Tamworth Highway Department. We were able to

complete several projects in 2012 such as the paving of Marsh Lane, Depot Road,

Washington Hill Road, High Street (top coat), and Turkey Street. We were also able to

grind and ditch Mason Hill Road and Cleveland Hill Road.

We continued to do other needed maintenance as time allowed such as replacing culverts,

ditching work and tree trimming/removal.

We were able to process about 7,000 yards of our own gravel from the Highway Garage lot

which will help keep the cost down.

I'd like to give a big thank you to the road crew for all their hard work which made 2012

very productive and to the sub-contractors for all their assistance as well.

If all funding is approved for 2013 we are looking to pave a portion of Cleveland Hill Road,

Mason Hill Road, Turkey Street, and Union Hall Road.

I'd like to send an additional thank you out to the Board of Selectmen and the Town Office

Staff for their support.

Fire Department Annual Report 2012

In the year 2012, the Tamworth Fire Department responded to 186 calls for assistance thru the 911 system. Types, Numbers and percent of calls are as follows;

Fire 27, 14.51% Rescues and EMS 59, 31.72% Service Call 17, 9.13%

Good Intent Call 26, 13.97% False Alarm & False Call 39, 20.96% Hazardous Conditions (No Fire) 10, 5.37% Severe Weather/Natural Disaster 2, 1.07% Special Incident Type 6, 3.22%

These numbers do not include all other calls for service received direct to the station or requested thru a member, which primarily consists of assistance to the public. In most cases we are on scene within eight minutes from time of dispatch, 26% of the time we are on scene in six minutes from the time we are dispatched.

The Tamworth Fire Department averages a roster of 30 volunteers with six being explorers, which is a national program for individuals between the ages of 15 and 21 to introduce them to the fire service and to provide training tailored to them. We have had a busy year with many members attending training outside of our monthly training schedule; many members achieving a new level of certification or enhancing their present level of certification. This year two more members have achieved Fire Fighter Level II, which is a significant amount of time and commitment invested on their part. I am truly grateful and proud of the accomplishments of our volunteers.

Over the last five years, the Fire Department has tried to keep our total budget the same or below the previous years. We have been able to accomplish this. In 2012 we were over budget on three line items due to unforeseen circumstances. We had a very expensive year for vehicle maintenance, radio repair/replacement, and the radio repeater project. That project was funded by a fixed grant amount and came in over budget. Vehicle maintenance is hard to predict what the future will bring for necessary repairs. By federal law, all of our communication equipment had to be "Narrow Banded" this past year. The reprogramming we knew about and budgeted for; however, there were significant funds expended due to unforeseen problems with some of our equipment not being able to be "Narrow Banded" or needing work to be compliant. It might appear that we were also over on our training line item; however, the dollar amount we over spent for training was able to be recouped thru grant funding which went back into the Town's general fund revenue.

The installation of the radio repeater system at Great Hill fire tower is an amazing upgrade for our operational capability. I cannot thank all involved enough for making this materialize. I am very thankful to the Tamworth Foundation for the majority of the funding and to all of the members and other volunteers that made this project possible. We utilize the repeater channel on almost every call we have now. It gives us the ability to better coordinate our efforts. So far, we have been able to access the repeater with our handheld 5-watt portable radios anywhere in Town and in most areas from our surrounding communities.

The Fire Department will be asking the voters to consider two major purchases for FY 2013. First, we have added \$27,500.00 to our operating budget for the purchase of ten complete sets of NFPA compliant turn out gear. This cost will be offset *IF* the Tamworth Fire Department is awarded a grant thru FY 2012 Homeland Security Grant IAW Presidential Policy Directive 8: National Preparedness (PPD-8). The Grant process is competitive with many communities throughout New Hampshire applying.

The Fire Department has and will continue to use the system of "handing down" turn out gear with the goal of keeping the firefighters most likely to be doing interior work outfitted with the best gear available. Interior firefighters are exposed to extreme temperatures and environments considered to be in an Immediate Danger to Life and Health (IDLH) situation so it is imperative to afford the best protection available to these people. Due to the expense of Structural Fire Fighting gear, we are now behind in compliance with current NFPA standards.

The second significant funding request would be to see if the voters would purchase a new vehicle for the Fire Department to replace the current 2006 Tahoe with 130K miles on it. The Capital Improvement Committee has recommended that we purchase this replacement vehicle in 2013 because it fits into the CIP better than the following 4 years. The last Tahoe handed down from the Police Department was an expensive piece of equipment to maintain and did not last until the Police Department replaced the current Tahoe in use now. For three months, I used my personal truck for Fire Department operations. I have an estimate of \$3,000.00 to repair everything that is wrong with the current Tahoe and there are signs of impending issues to come. The next Police vehicle to be replaced would be the Expedition; this is a 2007 with 120K miles on it and has known mechanical problems at this time.

The Fire Department and our community has had a fairly safe year. Keep up the good work and maintain all of your smoke and CO detectors. The life expectancy of CO detectors is five years and smoke detectors are ten years. If there is any doubt of age or reliability, replace them.

In closing the entire Fire Department wishes to extend heartfelt condolences to the families and to the community for the loss of some great individuals who have passed in 2012. They will be fondly remembered, especially ones gone before their time.

I would also like to thank all of the Volunteers, the Office Staff, the Highway Department, the Police Department and even Glenn at the Transfer Station for their outstanding cooperation and support.

TAMWORTH RESCUE SQUAD 2012 ANNUAL REPORT

Tamworth Rescue Squad is an all-volunteer department which services the citizens of Tamworth and surrounding towns by belonging to Ossipee Valley Mutual Aid Association. Tamworth Rescue Squad responds to requests from OVMAA along with Careplus dba North Conway Ambulance for assistance with medical support, transports and evaluation of patients.

This year Tamworth Rescue Squad received 411 calls from Carroll County Dispatch. 297 medical calls, 61 motor vehicle accidents, 51 fire assists and 2 mutual aid requests. Each year our call volume surpasses the previous year, this year remains consistent with the trend. We have also seen an increase in patient acuity related to shorter hospitalizations and more serious medical conditions.

Elected officers for 2013 are Captain Jeffrey Tavares, 1st Lieutenant Phil Rich and 2nd Lieutenant Scott Schwartz.

Along with the required trainings for members to keep with the current State of NH licensing laws some members have taken extra trainings. Tamworth Rescue participated with Tamworth Fire, Ossipee Valley Mutual Aid Hazmat Team and the 12th Civil Support Team from the Army and Air Force National Guard at the Tamworth Inn in September for training with hazardous materials and decontamination of patients. We still have 3 American Heart Association CPR/AED Instructors to continue trainings for the department and the town if anyone is interested.

Thank You again to the families of our dedicated volunteer members. It is not easy on the families every time the call for help goes out and the member leaves the family to help other people. We appreciate all the families support and sacrifice. We would also like to thank the late Guy Pennell for his dedication and help with setting up trainings for extrications. We are also thinking of the rest of the families in town who have had family members taken away so soon.

Another reminder to help us find your house more efficiently we will continue to sell the 911 signs so they can be posted near the road and should be free from obstruction. There are still many houses in town unmarked and adds to the response time while trying to locate the correct address.

2012 was a big year for TCNA. We completed a 12 month study done by the New Hampshire Institute for Health Policy and Practice at UNH. The conclusions proved what many of us already knew to be true; TCNA saves hundreds of thousands of dollars right here in Tamworth every year. If you would like to read the study results it is posted on our web page www.tamworthnurses.org or you can call our office and we would gladly mail you a hard copy. Our sincere thanks go to the Tamworth Foundation for funding this study.

For almost a century now, the Tamworth Community Nurse Association has offered Tamworth residents a wide range of services —with no fee for service to the patient. In fact, we try to save you money. Some of you may have noticed that this fall seasonal flu shots were being advertised for \$38.00 in North Conway, while Tamworth residents received inoculations for our cost of \$15.00 - an overall savings for Tamworthians of \$4232! In addition, many residents take advantage of ordering medical supplies that are not covered by insurance through our office and have realized considerable savings over the retail market. We also have equipment available to loan out. Before you rent a wheelchair, purchase a high-rise toilet seat, buy crutches or a walker, give us a call, no matter what your healthcare need. There's a good chance that we can help you in some way.

The handicap accessible TCNA Office at the back of the Town Office Building is open Monday through Thursday from 9:00 to 2:00 and from 9:00 to 11:00 on Fridays. A nurse is available in the office everyday from 9:00 to 11:00. Appointments are not necessary and all issues are treated with strict confidentially. We assist people of all ages from newborns to seniors with no regard to economic strata. Stop in or contact us at 323-8511 or tamworthnurses@yahoo.com.

Dr. Brian Irwin of Tamworth Family Medicine is our Medical Director. Our nursing staff includes Joan Peters, RN, Carol Eldridge, LPN, and myself. Dave Deveau is our administrative assistant and coordinator of the Meals-On-Wheels program. It is a pleasure to work with this competent and committed team. Each of us plays an integral part in the services TCNA provides to Tamworth residents.

Our Board of Directors meets regularly to direct agency functions and operations, handle financial matters, as well as assisting with fund raising events. The 2012 members of our Board of Directors were Chele Miller Chair, Kent Hemingway Sr. Vice Chair, Cathy Baybutt Treasurer, Bob Seston Asst. Treasurer, Geoffrey Burke Secretary, Lorraine Streeter, Leslie Johnson, Nina Perry and Mary Watkins. Chele Miller has been Board Chair for the last four years. With her leadership TCNA has done Strategic Planning, revised our By-Laws as well as Policies and Procedures. Committees have been streamlined and of course the UNH Study mentioned above completed. She is now turning over the reins to Mary Watkins who has graciously agreed to become Board Chair. Chele won't be wandering far from the Board. She is joining our Program Committee and looks forward to meeting the upcoming opportunities that await TCNA. On behalf of the staff of TCNA I would like to say "Bravo and well done!" to Chele for all of her efforts. It has been an absolute pleasure to work with her for these past 4 years. The TCNA Board receives little recognition, but their steadfast leadership of this fine organization makes our services possible.

We coordinate Meals on Wheels, an essential service to many town residents who, without the benefit of this service, would be hungry or at risk of malnutrition. This program also serves as a regular safety check. There were 9,730 meals delivered to town residents in 2012 by volunteer drivers. We always need more volunteers to work a flexible schedule once a month. It only takes approximately two hours to complete the route, and the opportunity to serve others is rewarding.

TCNA continues to function as the Salvation Army Unit station for the area. Emergency funds are available for Tamworth and Sandwich residents in need. This year we have assisted people by providing medication, therapy, groceries and medical equipment.

During the holidays, we deliver gifts to our clients. Special thanks to The Tamworth Community Christmas Project for their support to this program. We also worked closely with St. Andrew's Food Pantry in distributing more than twenty Thanksgiving food baskets.

TCNA interacts and coordinates services with the Tamworth Caregivers, ServiceLink, Tri-County Cap, and RSVP, to name a few. These organizations have provided support to many area residents and serve as important members of the health care team.

The Tamworth Community Nurse Association is a private, not for profit, non-certified company. This means we do not bill individuals, Medicare/Medicaid or insurance companies. Much preventative care and social service support which your neighbors often need to maintain active and healthy lives is not covered by the major insurance companies. Regional health agencies, including the VNA, regularly contact us to care for patients in Tamworth whose coverage has been terminated. TCNA saves money for our clients while providing services and support.

It is the mission of TCNA to care for all Tamworth residents, including those who, for any number of reasons, fall between the cracks of the health care system. We provide the safety net. We are

well known to area hospital discharge planners and work cooperatively with them to provide optimal home care. Because we are not Medicare certified we do not provide ancillary services such as occupational, physical, and speech therapy, home health aides/homemakers, and hospice. For these services we rely on area agencies such as the VNA's, Carroll County Health & Homecare Services and out-patient Physical Therapy offices. Close communication and collaboration allow us to provide continuity and holistic care. We are grateful for the cooperative efforts extended to us by these agencies.

Our Annual Meeting will be at the Brass Heart Inn on August 21st at 6:30PM. Of course we will have music, blueberry ice cream and an interesting topic to explore. The 4th Annual Concert to benefit TCNA will be held in early September at The Barnstormers Theater and lastly our Holiday Gala will take place on Friday, December 6th with the location to be announced closer to the date. These events serve as fundraisers for TCNA but they also do so much more. They help us build grassroot support while giving us all a chance to recognize what an extraordinary and unique organization TCNA is. Please, write these dates down and plan to join us as TCNA enters its' 92nd year of caring for Tamworth.

As always, we deeply appreciate the support of the people of Tamworth and pledge to continue our efforts to work for the health and well-being of the community and of each Tamworth resident.

Tamworth Caregivers: 2012

Thank you Tamworth Board of Selectmen and residents for your support in 2012.

The Tamworth Caregivers focuses on what is most needed by Tamworth residents within our mission.

The mission of Tamworth Caregivers "is to develop support services provided by volunteers to serve residents who, from time to time or, on a continuing basis, require assistance to meet their daily obligations and / or enhance their quality of life."

In 2012, the TC responded to 673 requests from Tamworth adults for transportation. A total of 28,740 driven miles (12,640 miles of long distance) and 2,200 volunteer hours supported neighbors' interest in remaining in their own homes while being able to address their basic needs, health care and quality of life interests. Thank you volunteers for enjoying conversations with your riders as you travel to hospital and doctors appointments, grocery and pharmacy shopping, banking and mailing stops and to community events.

During the 2011-12 school year, TC OASIS intergenerational tutoring program provided twenty-one K.A. Brett Elementary children with 833 volunteer tutor hours. During OASIS' third year at Brett, nineteen tutors met once a week for an hour with children in grades K-4. Tutors, teachers and staff were invited by Sue Colten, OASIS volunteer coordinator, to OASIS training sessions and special in-services. Thank you tutors for joyfully enhancing reading and language skills of our children.

Our community has a proud history of neighbor helping neighbor. Tamworth has approximately 2,837 residents; 30% of us are over 55. The primary interest of this age group is 'aging in place' (AARP 2012 member survey)— to live comfortably in their home and connect with people of all ages. Since 1999, the Tamworth Caregivers has listened to their neighbors' keen desire to remain independent but connected to community. The town of Tamworth's annual support and the Caregivers' thoughtful donors make living in beautiful, rural Tamworth a positive non-isolated experience for residents.

The Tamworth Conservation Commission is a town organization staffed by appointed volunteers. It advises the Planning Board and the Selectmen on matters related to conservation, with specific responsibilities related to wetlands. In addition, it oversees some of the Town's conservation lands, its trails, and its conservation easements. Meetings are held on the second Monday of each month at 7:00 pm at the Town Offices. The public is always welcome. Noteworthy activities of the Commission during 2012 are summarized below.

WETLANDS The Commission consulted with the Planning Board and the Selectmen on several matters, in accordance with the Tamworth Wetlands Conservation Ordinance. Most such consultations begin with fact-finding and site visits. Reviews this year included Special Use Permits for a driveway culvert replacement and a footbridge over a wetland. A waiver for repair of a failed septic system was also reviewed. Commission members responded to two citizen concerns regarding construction projects possibly impinging on wetlands. Following Tropical Storm Irene, the Commission made site visits to review work done by PSNH to restore a power line over the Swift River which was damaged by flooding; and, at another location, reviewed a plan to restore and stabilize an eroded brook embankment and create an overflow path around a historic stone bridge to manage future flooding events. Much work went into reviewing a wetland area highly impacted by earth moving, aggregate removal, and incursion into a major brook and to participating in the plan and permit to remediate and restore the area. The Commission also provided input into a review of the FEMA Floodplain Map for Tamworth.

As inauspicious as they may seem, wetlands are the backbone of healthy ecosystems. Though some are easily identifiable ponds, marshes or waterways – scenic and rife with vegetation and wildlife from large to microscopic – others lack eye appeal and escape notice; but, flashy or not, all are critical to protecting water quality, preventing erosion, managing run-off, controlling flooding, sustaining and housing a wide range of wildlife, and recharging our unique and invaluable stratified drift aquifer. It is incumbent on the Conservation Commission, and on each citizen, to protect our wetlands and the buffers that help safeguard them from degradation. We trust all residents will educate themselves on the value of our wetlands and vote to maintain our Wetlands Conservation Ordinance. The Conservation Commission has joined the Planning Board in unanimously opposing both petitioned ballot initiatives that will be voted on at town elections on Tuesday, March 12th.

The Conservation Commission continues to provide financial support for the extremely valuable, on-going water quality monitoring of local rivers carried out by Green Mountain Conservation Group and receives annual reports on that work, which are available upon request.

<u>CONSERVATION EASEMENTS</u> An easement was completed with the owner of the Bearcamp Valley Farm in South Tamworth to protect a second field on the north side of Route 25 from development. This also protects views of the Sandwich Range and frontage on the Bearcamp River, an important wildlife crossing.

An effort has been initiated with the Society for the Protection of NH Forests to increase an existing forest block and enhance connectivity by protecting the Reich Lot on Hackett Hill adjacent to the Gilman Forest on which the Town already holds an easement.

Both easements maintain the properties in private ownership and on the tax rolls while significantly advancing the ongoing effort to ensure wildlife connectivity between the Sandwich Range and the Ossipees. A critical and time-consuming responsibility fulfilled by the Conservation Commission is the annual monitoring of all conservation easements.

TRAILS & GREAT HILL TOWER Another responsibility fulfilled by Commissioners, often with assistance from citizens, is the maintenance of the Great Hill Tower and the Town's six trail networks—Jackman Pond, the Earle Remick Natural Area, the Big Pines Natural Area, the Black Spruce Bogs at the Harry Damon Preserve, Waterfowl Haven, and the Tower Trails. Easy access and safe passage are monitored, and map boxes and signs are mounted and maintained. This year, an old well at Waterfowl Haven was capped to eliminate hazard, the Big Pines Trails were improved and all trails were checked after Tropical Storm Irene. In addition, at the request of NH Fish and Game, the Commission assumed responsibility for the eastern portion of the Bearcamp River Trail in the Hackett Hill Management Area. The first order of business required restoring/rerouting approximately 100' that had been obliterated by logging. The Commission facilitated the replacement of the landmark Big Pines sign on Chinook Trail and expresses gratitude to the NH Division of Forests and Lands for its skillful restoration and to Roberts Excavation for its remounting.

To date, our Hikin' Herons program has prompted 53 residents, visitors, neighbors and canine companions to experience the trails and earn a Hikin' Heron patch. This program continues; pick up information at the Town Office or the Cook Library, and earn a patch!

<u>FORESTRY</u> The state completed a significant timber cut on Hemenway State Forest in 2012. In response to questions and concerns raised by residents, the Commission invited state foresters to attend a Commission meeting. They presented a detailed overview of the natural resource protection, public use, timber management, and economics of state forests and engaged in an informative discussion with those in attendance. The meeting underscored how fortunate Tamworth is to have Hemenway State Forest. The Commission will continue to provide educational opportunities for local citizens to learn more about local resources and how they are managed.

OTHER FUNCTIONS

- Landfill Monitoring Commissioners carried out the required annual monitoring of the landfill, thereby saving the cost of having that done by an outside agency.
- The GRANIT database inventory of conservation lands in the state was updated to include all Tamworth easements.

- At the request of the Chocorua Lake Association/Chocorua Lake Conservation Foundation, Chairman Ned Beecher provided an informational slide talk on land protection. The Commission recognizes the invaluable, long-term work that the two Chocorua Lake organizations have done over decades to keep that lake a vital and beautiful resource for the Town.
- July 4th Family Day & Parade Commissioners and friends created unique, human-size wetlands creatures and won recognition as the Most Original Float in the parade. Thanks to the Mahoney family for their inspiration and energy in this!
- The annual May Wednesday morning Bird Walks were again led by Ned Beecher and will be in late April and May of 2013.
- The Household Hazardous Waste Days were held in late July and early August, organized by Lakes Region Planning Commission and with Tamworth working in conjunction with Moultonborough and Ossipee. Chris Clyne once again did the local effort and organizing. Over the past three years, 5% of Tamworth households have participated, helping the multitown effort keep thousands of pounds of hazardous waste out of the environment. A full report on this event is available upon request.

Cook Memorial Library Director's 2012 Annual Report

Mission Statement: Cook Memorial Library provides educational, cultural, recreational and information resources through the work of its dedicated and knowledgeable staff. The library offers opportunities for learning, leisure reading, local history and genealogy preservation, study and research. It is accessible to all as a welcoming and comfortable center of community activity.

In 2012, we continued to implement the goals we delineated in the 2010 Long Range Plan: *outreach* to Brett school, TCNA, Remick Acres; *collaboration* with other entities in Tamworth and surrounding towns, such as Tamworth Historical Society, Remick Museum, Altrusa, Tin Mountain Conservation Center, Town of Tamworth, to name a few; *technological development* in the form of research conducted on the choice and purchase of a new automation system (ILS); over \$10,000 of capital improvement funds spent on *preservation of the building & grounds*; continued *collection maintenance* by careful acquisitions and discards; the *recruitment and retention* of excellent staff (including the new hire of an MLS-enrolled student.)

Explanation of unexpended money to be carried over to 2013 budget: \$1090.59 in Barbara Fromm Memorial Fund; \$839.86 in Joseph Rancourt Memorial Fund, \$1062 in Tamworth Foundation Grant for cemetery management software to be installed on library server. In addition, the Trustees of Public Funds for the Town of Tamworth hold approximately \$52,000 in restricted funds designated for the library.

As of December 31st, 2012, the total number of library materials in the collection was 23,509. 1506 titles were added during the year, and 1536 titles were discarded.

In 2012, 879 borrowers checked out 30,620 library materials. There were 15,301 library visits recorded. The staff answered 1608 reference questions, 742 of which were technology-oriented.

As always, we are deeply indebted to all the donors and volunteers who supported the library in various ways throughout the year. The Friends of Cook Memorial Library are to be especially commended for all the hard work they have done on behalf of the library. The Friends provide financial support for virtually all library programming. They also fund purchases of equipment and supplies, continuing education opportunities for staff, our Overdrive membership (which provides access to downloadable audios and ebooks) and our movie licensing (which allows us to show films publicly). There were 2239 downloads of library materials at Cook in 2012 – a very popular service. Without our Friends and supporters, the library couldn't offer the range of services that it does.

This year the Friends are also contributing a sizable sum toward the implementation costs of a new automation system for the library. Switching automation systems is a time-consuming and daunting task. Training for staff on the new system will take a considerable amount of extra staff time. With support from the town and our Friends, this project will have adequate financial backing to be implemented successfully. In all, the Friends of Cook Memorial Library will donate nearly \$7000 toward the library in 2013.

John Roberts & Willie Farnum both spoke in favor of this article – Bob Abraham was not in favor of expenses under this article pertaining to the build out analysis or legal fees under the Planning Board budget. David Giampietro asked for clarification by the Selectmen for overall increases in the budget. He stated that he could explain where the increases were but thought it best if the Board could elaborate.

Steve Gray spoke of the need for the increase of the legal line as \$22,000 was the amount spent back in 2007. There are currently two legal court litigations pending for 2012 and money is needed in the appropriations. The \$12,500 amount for the Build Out Analysis has been budgeted, and as a recommendation under the Master Plan, is being appropriated to benefit the town's potential layout of land use & building development.

John Wheeler asked again for clarification on the general government operations budget, and there was discussion that health insurance would be increasing by 7.57%, and the Dental program would be decreasing by .02%.

Robin Gordon spoke of the need for legal fees to be appropriated in order to cover any pending litigations expected in 2012. Ned Beecher spoke of Conservation Commission's support of the Build Out Plan for the preservation of Tamworth in needing to be cautious not to over conserve the land but to leave room for growth in proportion to the land available for development.

Bob Abraham made a Motion to amend the article decreasing the total amount to \$746,053 by removing the \$12,500 for the Build Out Analysis, and reducing the legal fees by \$9,000 in the planning board budget. The amendment was seconded.

Steve Gray spoke of the budgeted/expended amounts on the legal lines from 2007 thru 2010 under the planning board budgets. Gerrit Zwart asked for explanation of Build Out Anaylsis. The analysis would take the land, subtracting lakes, streams, & roadways, and with consideration of state & local regulations, figure maximum "build out" for future planning of safety services, etc. This analysis would also be considered when updating the town's Flood plain maps that are currently outdated. Willie Farnum spoke in reference to money that is not spent when appropriated being put back into the general fund. Mary Breasted Smyth asked for Attorney Sager to give estimate of legal fees. Atty Sager commented on the two cases this year, one being quick in Federal District Court and the other being the Race track negotiations. Gerrit Zwart asked Robert Abraham to clarify his feeling on the issues. Bob Abraham felt that the appropriation for the Build Out Analysis was not a priority at this time, and felt that the increase in the amount for legal fees budgeted in the planning board budget was significant.
