Call to Order: 3:45

Approval of Minutes from Jan. 3, 2024

Minutes unanimously approved.

K. A. Brett School Energy Audit Update:

A Level 1 Energy Audit was completed by Noah Fioravante, of GDS Associates on November 22, 2023. He was escorted by Roy Roberts, Chief custodian and was accompanied by John Kumm of TEC.

According to Administrator Heather Sherwood and School Board Chair Jack Waldron, when the school HVAC renovation project was scoped, estimated, and designed by Meridian last year they worked closely with an Eversource representative, and found no significant potential for energy efficiency savings.

An HVAC system is currently in the works. This project is scheduled for construction in the summer of 2024. The design is complete, piping has been purchased, but the mechanical equipment has not been purchased. Noah is attempting to work with Meridian and Eversource to determine if there are potential savings.

Climate and Community Program at UUFES

TEC was invited to participate in a recent program hosted by UUFES on climate and community. John was able to represent the Tamworth Energy Committee.

Finding New Energy Committee Members:

Ellen will complete her one-year term as Tamworth Energy Committee secretary in March. She has offered to serve as an alternate for the upcoming year. John will assume the secretary role for the short term.

Discussion and Planning for EV Expo

Ted has composed and sent an email to Jim Hoenscheid of Club Motorsports requesting help in planning a Spring 2024 event.

Ted's email covers the following points:

- Request and finalize a date for the EV Expo,
- Confirm time,
- Confirm an hour of driving laps in vehicles (Club Motorsports typically opens the track to their members at 11:00. Our expo may cause them to delay their opening for members for an hour.)

- Confirm who will organize the Classic Cars portion of the event: will their members bring their classic cars, or will both TEC members and Club Motorsports put out the word for local classic car owners?
- Ask whether private EV owners could display (and possibly drive) their cars.

TEC will begin to reach out to car dealerships and will ask them if they are willing to participate in a future event. We estimate 40 to 60 members of the public will attend the event. We will be seeking both plug-in hybrid and all electric vehicles.
