#### **Old Business:**

Chief Colcord presented a letter from the Selectmen regarding authority Town Officials to sign paperwork regarding easements. The letter states that the Selectmen have the sole authority to purchase, sell and grant easements to Town owned real estate property. The Board agreed that this is likely true. There are currently no such actions pending so the letter will be filed

Chief Colcord discussed a fire permit that needs to be revoked at the apartment building next to the Central Fire Station.

Chief Colcord mentioned that he has ordered a new 4-Gas Meter and at the moment we have a loaner from Fire Tech and Safety.

Chief Colcord said he will start looking for an intercom for Hose 1, he mentioned we still have the rear speaker and just need the head module. J. Hartley mad a motion to approve to spend up to \$1,200.00 for a new intercom. Seconded by H. Remick. All in favor.

Chief Colcord discussed Car 1 will need a new mobile radio.

Chief Colcord decided he will be changing the lock on the office door and issue new keys to appropriate members.

Chief Colcord read a letter from Wakefield Fire Dept. regarding a fundraiser for Wakefield Captain Morrill and his family. The Board decided that this should be referred to the Firemen's Club to see if they would send a donation and card.

Chief Colcord discussed a new call sheet and discussed inactive members. Chief Colcord will follow up with Scott Schwartz. Scott Finman and Shannon Ruhf were also discussed.
