## **Approved Meeting Minutes**

**CALL TO ORDER:** Select Person Goodson called the meeting to order at 5:30 pm and made a motion to go into Nonpublic RSA 91-A:3 II (a), Doucette seconded, roll call vote Doucette yes, Goodson yes, Prentice yes, Behr (over telephone) yes. Chair Roberts joined the nonpublic at 5:45. Roberts made a motion to come out of nonpublic at 5:55, Goodson seconded, roll call vote Doucette yes, Goodson yes, Prentice yes, Behr yes, Roberts yes. Roberts called the meeting to order at 5:57 pm. Those present are Select people Doucette, Goodson, Prentice, Behr (via Zoom), Roberts, Town Administrator Myer, Ed Comeau, Zach Remick, Bruno Siniscalchi, Kelly Rines, Linda Cook, Ellen Farnum, Richard Roberts, Gabrielle Watson. On Zoom: Brad Cintier, Maureen and Jim Diamond, Linda Eldridge.

#### **NEW BUSINESS:**

- Road Agent Report: Lots of tough storms in recent weeks, and the team is keeping up with it, and
  everything is going well. Expressed concern about lack of snow making for a messy spring. Excellent
  coordination from Eversource. Road agent thanks the support from the towns people during the
  storm. Members of the public applauded the Road Agent for his excellent work.
- Energy Commission, Ellen Farnum, Gabrielle Watson: Ellen Farnum thanked the Select Board for the lovely holiday luncheon that was held for staff and volunteers. Gabrielle Watson noted that there used to be an Energy Committee in Tamworth. With energy prices being so high and volatile she suggests creating a committee to research reducing costs and tax dollars. Work would include research, conducting energy audits, provide options on how to reduce energy use and costs. Ellen Farnum added that working with the recycling project has been an eye-opener on how big a job it is to write public grants. Prentice asked: is anyone looking at what are other towns doing to reduce costs? Discussion ensued about whether to appoint a committee, there are pros and cons. Doucette motioned for the town to establish an Energy Committee and post to get volunteers to staff it with five members, Goodson seconded, roll call vote Doucette yes, Goodson yes, Prentice yes, Behr (over telephone) yes, Roberts yes.
- Emergency Planning & Processes, Zach Remick presenting. Handed out an emergency management staffing plan, from the 2021 manual. Here to discuss policy. In the last storm there were requests for shelter from the public, and a town policy on when to open a warming shelter, or an emergency shelter would have been helpful. There is also the issue of the generator which is not reliable. Zach met with the State this week to see if there is a grant for a generator: as the first one was state funded it is not clear if we can get a second grant, the state representatives are looking into it. Prentice asked why our generator is such a lemon. Short answer: Bad design. Mr. Remick requested there be a select board member he can work with in an emergency. Select Chair Roberts suggested he would be the point of contact. Remick will draft a policy that the select board can work on. Comeau asked if we had identified ham radio operators. The communication challenges are significant. Remick confirmed we do not need to update the emergency disaster plan.

- Health Insurance and FSA Calculations: Myer explained that she and the Finance Manager has
  discovered inconsistencies between the Personnel Policy and the implementation of the Dental Plan.
  Myer stated she would do more research. Myer then shared that the town has been unintentionally
  overfunding the FSA, according to Health Trust contact Andrew Struth. We will have to correct, and
  could potentially offer an Health Reimbursement account as an option to the employees. SB opted
  to defer decision until next week.
- Groundwater Protection Ordinance, Enforcement Research Memo: Doucette reviewed the purpose
  of sending a memo, and that we need to know what enforcement would involve. So he has drafted a
  memo to the Planning Board. Goodson motioned that we send the memo as drafted to the Planning
  Board, Doucette seconded, roll call vote Doucette yes, Goodson yes, Prentice yes, Behr (over
  telephone) yes, Roberts yes.

#### **OLD BUSINESS:**

• Encumbrance Update – Contracts are in place for all encumbrances. Cook and Prentice requested a copy of the contract for the Town House.

#### **ADMINISTRATOR REPORT:**

- Account Balance: \$3,657,462.
- Myer reported that she has been working on the Warrant Article, FSA issues, Open Enrollment, budgeting, and continues to work on tax deeding and junk yards.
