Batch and Nelson are re-upping. Conservation Commission is looking for alternates. There is still some review happening of the view cut on Chocorua Lake. There is legislation pending that will give monies from the timber tax to the Conservation Commission.

**Old Business:** Cassandra has requested information about a cell tower bond on Durrell Road, but the Board does not believe that it has the information she is looking for.

Faith Hadden – a copy of the deed registration showing book and page was made and mailed to her.

**New Business:** A discussion was held about reinstating the wetlands ordinance. Perhaps mirror the state ordinance with some minor tweaks to make it unique to Tamworth.

Law books were delivered and passed out to members present.

At the March meeting, officers will be elected. Someone will need to take the position of treasurer. Alternates need to be recruited.
