August 27, 2014

Meeting was called to order at 7:00 pm.

Treasurer: Tom reports that to date we have spent \$2572.64, with \$19335 remaining in the budget. \$831.32 has been spent on legal fees. Pat would like to know if there is a way that we can use the money that is left over to begin some water sampling programs in town.

Capital Improvements Committee: David reports that the CIP met last night, and the meeting was continued to next Tuesday for rating and ranking. The plan is to deliver it the CIP to the Planning Board on September 24 and the Selectmen on the 25th.

Economic Development: Pat reports that there was no meeting in July, but they did meet in August. The Agribusiness meeting will be held on November 1 from 10-12 or 1 at the Tamworth Town House. Lunch will be served. This is for farmers markets, restaurants, and grocery stores.
