Treasurer: Tom reports that as of 11/7/13, \$7000+ is left in the budget.

Secretary: David Little reports: LRPC hosts Kimon Koule's retirement party on 11/25/13. The Chocorua bond has been

released.

Ordinance Review Committee: no report

Economic Development: is working on Tamworth Teen Leadership. MW Valley Economic Development meeting re: TIF - **Meeting** at Cook Library, Tuesday January 14, 6:30.

LRPC: LRPC is looking for a Tamworth Commissioner. Dom will post on the Exchange.

Selectmen: Re: Albee Road cell tower – awaiting explanation/information concerning reflectors and effect, if any, on tower camouflaging.

Conservation Commission: TCC and Cook Library will co-sponsor a presentation by Eric Masterson, author of *Birding in New Hampshire*, in late winter. Becca reported on the Conservation Land Committee's considerable progress with the easements, purchase and sale agreements, and financing of the Floyd (Bearcamp Farm) and Gilman West/Reich properties.

Subdivision -- Conceptual Review John Reggiero and Kathleen Lang Map 209/17 and Map 404/18

Location of Subject Properties: Whittier Rd

The review was opened at 7:16 pm. Diane Smith of Thorne Surveys, agent.

This Conceptual Review is for a 2-lot subdivision of a lot with considerable floodplain land. Discussion included the 1982 subdivision, location of lots, adjoining lot limited to agricultural use, and necessity for waivers. A non-binding straw poll indicated general support among the members for waivers to approve the subdivision.

In re: ATT Personal Wireless Services Facility, Durrell Road Map 414-010 Lot 200

Carl Aquilina of SAI representing ATT&T. Discussion included this application's issue with run-off and abutting lot. Dave C explained the problem, design of corrective proposal, extent of the applicant's responsibility, and impact on wetland. Carl Aquilina and Board members discussed plans including a driveway permit, culvert work, state wetlands permit, and antenna replacements.

A **Motion** (Dave C/Jim) to notify the Selectmen that the conditions for approval of the PWSF Site Plan Review have been met, provided that the applicant applies for and receives a driveway permit (reconstruction). APPROVED
