Vol 9, Pg 144; 1969-03-11-31 – Voted down tarring section of Fowlers Mill Road, Myrtle Walker's toward 113A.

Vol 9, Pg 148; 1970-03-10-21 -- Voted to continue the name Fowlers Mills Road from its intersection with Philbrick Neighborhood Road to Route 16.

Vol 9, Pg 148; 1970-03-10-21 – Voted to continue widening Gilman Valley Road.

Vol 9, Pg 169; 1971-03-09-26 – Unknown. Discontinue old section of Washington Hill Road, probably at the intersection of Rte 16. Ron and Dave B. will investigate.

Vol 9, Pg 170; 1971-03-09-29 – Voted down tarring Fowlers Mill Road.

Vol 9, Pg 170; 1971-03-09-30 – Passed over reopening Hackett Hill Road.

Vol 9, Pg 205; 1972-03-07-34 – Discontinue section of Philbrick Neighborhood Road at Sedgewick; Lori will check deed.

Vol 9, Pg 226; 1973-03-06-34 – Old route 16 north of Fowlers Mill Road.

Vol 9, Pg 245; 1974-03-05-32 – Voted to repair bridge over Wonalancet River on Fowlers Mill Road.

Vol 9, Pg 263; 1974-12-22-00 – Letter to State accepting Washington Hill Road layout at intersection with Route 16.

Vol 10, Pg 12; 1977-03-08-42 – Passed over Poco Drive.

Vol 10, Pg 25; 1978-03-14-47 – Did not Pass Poco Drive.

Vol 10, Pg 38; 1979-03-13-47 – Passed over closing Old Rte 16 near town beach to traffic.

Vol 10, Pg 38; 1979-03-13-48 – Passed over rods in Levy subdivision.

Vol 10, Pg 40; 1979-03-13-53 – Passed over closing Jeffers Bridge Road.

Vol 10, Pg 40; 1979-03-13-54 – Passed over article to replace Jeffers Bridge.

It should have two sections: one organized by individual roads and listing all the actions that pertain to each road, and one organized chronologically and can be based on the spreadsheet Chris has developed. But the “town meeting records” spreadsheets now have a (located?) column, which shows the names that need to be researched. It is complete up to 1840 in Volume 3.
