## Volume 4

1851-03-11-15 – Unknown. Could be old layout of Philbrick Neighborhood Road from the goat path to Loring Road or Goat Path between end of old layout and Lake Chocorua Road. Depends on location of W. Buzzell's and which one of two locations for H. Chick. Also, see 1852-11-02-04 and 1852-03-09-13.

1851-03-11-16 – Article to lay out road dismissed. J. Miller lived in the Posner House. (If Walls Could Speak).

1851-03-11-18 – Authorization by Town for Selectmen to lay out if they choose. Franchi to Wonalancet Farm. Names fit.

1851-11-04-00 - Locke Falls Rd east end with overlap on 1843-04-12-00. Plot fits well, names fit.

1852-03-09-10 - Road across parade ground. Names and location fit.

1852-03-09-11 – see 1851-03-11-16 and 1852-06-20-00 and 1853-03-08-10, which is referring to 1792-02-10-00.

1852-03-09-13 – Article to discontinue was dismissed. Subject road was either Goat Path from Chick's to Loring or the old Philbrick Neighborhood Road from Chick's to Loring.

1852-03-09-17 – Article to discontinue 1851-11-04-00. No action recorded.

1852-06-05-01 – Cleveland Hill Road from old Meeting House site to four corners. Plot fits and names fit.

1852-06-05-02 - Bryant Road from Smith to Holden. Plot fits, names fit.

1852-06-30-00 - South end of Breakneck Hill Road. Geography fits, See 1852-03-09-11.

1852-11-02-04 - See 1852-03-09-13. Where did Joshua Horn live? PNR or Goat Path?

1852-11-02-06 – Unknown. Could be same as 1853-03-08-10. Also, see 1852-03-09-11 et al.

1853-03-08-10 – Discontinuance of 1792-02-10-00, an early version of Breakneck Hill Road that started at the junction of Cleveland Hill and Bunker Hill Roads. J. Miller is in If Walls Could Speak (Posner House) and NH-GRANIT LIDAR layer shows a linear feature that fits original layout.
