

## **Tamworth Road Study Committee**

Draft Minutes – November 1, 2023

**Call to Order** – Meeting came to order at 7:05 pm. Members present were Paul King, David Little, David Halpin, Lori Gerard, and Chris Conrod. Members absent: Willie Farnum and Ron Remick.

**Abenake Land Acknowledgement Statement** – Paul acknowledged that this meeting was taking place on land originally occupied by the A'Dakinna people.

**Review Minutes** – Minutes of 10/04/2023 accepted as written.

### **Ancient Business**

Paugus Road and Fowler's Mill Road – Between Paul's review of the 1829-07-09-00 layout and David L's research on the road that parallels Paugus Brook on the west side, it was agreed that two facts were confirmed: First, the 1829-07-09-00 layout is a sloppy description of the western half of Fowler's Mill Road plus Paugus Road to the town line. Second, the Old Paugus Road, so called, is and was always a private road.

Breakneck Hill Road – Dave H reported that he could not find info on the Meader-Gilman property line locally and that it would require a trip to the Strafford County Registry of Deeds.

Paul reported that he encountered more information on DOT records and he would be revising the 113A report.

Regarding 1824-10-11-00, David L. reported that his research locates Eben Dow somewhere near Bearcamp River, and not near the area of Fowler's Mill.

### **Old Business**

Durrell Road – Paul found a road action missing in the report (1984-03-13-30). Report needs revision.
