- TCNA Fundraising Letter of Support Request, June Aprille Updated on the TCNA building Project there is an opportunity for a large award from DCFA. Aprille read the draft letter for the public record. Roberts asked about the cots of the project, currently it is estimated at \$1.3M.
- Paving Bid Discussion: There are two bids for the paving work this year. The bid from GMI is \$117,737.90, while the price from R&D is \$227,687.30 for the same work. The Road Agent recommends the town hires GMI Paving. Roberts motion to approve the proposal from GMI for the paving of Washington Hill Road and Depot Road, and and the reclamation of Great Hill Road in the amount of \$117,737.90. Rines asked about Scott Bridge repair, Roberts informered her that it will be repaired this spring/summer. Richard Roberts has found a company that can do the bridge for much less.
