Meeting Minutes

CALL TO ORDER: Roberts called the meeting to order at 6:00 PM.

NEW BUSINESS:

- Sanborn Head Discussion, Glenn Johnson Sanborn Head called to say they are coming in to do boring tests on the ground. They will be drilling down about 20 feet. Glenn will meet with them, they will be there for three or four days. The Select Board thanks Johnson for coming in.
- **Fire Department Update**, Chief Colcord: everything is going well, no calls on motorcycle week. Budget looks like it is right where it should be. Said that the town's idea of repurposing the old rescue vehicle is fine with them. Myer asked when it would be delivered. They are not sure. It will hopefully be less than a year. Myer asked if it in good shape. The old rescue vehicle is from 2006. 33,000 miles on it. Runs on diesel. New rescue vehicle is a Dodge, Behr asked if it comes fully outfitted comes with lights and sirens, lettered and everything. Schaeffer asked if the SCVA Compressor grant has come through? They are optimistic that the grant will come through, and discussed how outdated their departments air bottles are. Really in need the updated equipment.
- Rescue Vehicle Discussion Myer mentioned that the mileage budget is going to go over, Prentice will speak with Police department about using their vehicle for maintenance, at least for the fall to save money. A discussion ensued about Rescue vehicle as maintenance, board seemed positive. Cost assessment needed.
- Zoning Board of Adjustments, Board Assignment Steve Schaeffer volunteered to be the representative to the ZBA with E. Roberts as alternate.
- **Economic Development Council Membership Discussion**: Schaeffer stated that Pat Farley will be moving, and so she will become the Alternate, and Greg Hufford will become a commissioner. Prentice motioned to appoint Greg Hufford as a Commissioner, and Pat Farley as an alternate, Schaeffer seconded, roll call vote Behr yes, Schaeffer yes, Prentice yes, Roberts yes.
- Ordinance Adoption Process: Prentice is sharing the steps that a voter or a group can use to introduce an ordinance to the town at town meeting. The Select Board can put an item on the warrant, or voters can put petition articles on as citizens. They would draft the warrant and circulate the article for other registered voters to sign, 25 voters, or 2%, whichever is less, but no less than 10. The number of registered voters for this purpose is based upon the list of voters who were registered immediately prior to the last general election.

The original petition must be filed with the Select Board no later than the 5th Tuesday before town meeting. For 2024, this would be February 6, 2024 (5 Tuesdays prior to March 12, which is the 2d Tuesday in March). The Select Board forwards the petition to the Town Clerk, who reviews it to determine whether there are enough registered voter signatures. If the petition has enough signatures and is filed in time, the Select Board must include it in the warrant for the next town meeting. Traditionally, any article that is petitioned onto the warrant will include a note at the end of the article that it was "Submitted by Petition."
