Grant Application Bootcamp

Bootcamps Launch in January and Focus on 5 Grant Opportunities

Deadline for Registration is Friday, December 16

You do not have to be NLC members to register!

The Local Infrastructure Hub and NLC are launching five new bootcamps this winter aimed at helping small and mid-sized cities with populations up to 150,000 develop competitive funding applications for federal grants available through the Bipartisan Infrastructure Law.

The bootcamps kick off in January and focus on five grant opportunities:

1. Energy Efficiency and Conservation
2. Charging and Fueling Infrastructure (electric vehicles)
 3. Safe Streets (action planning)
 4. Safe Streets (implementation)
5. Brownfields

The deadline for registration is Friday, December 16. Cities do not have to be NLC members to register. Cities can register online at: <https://localinfrastructure.org/application-bootcamp/> (this link also includes FAQs about the program)

Towns and cities participating in these programs will receive support from NLC to develop a robust federal grant application, including access to templates, example submissions, and other resources that make for a well-composed application. The program provides a range of supports, including access to subject matter experts, individualized coaching sessions, office hours, and peer-to-peer learning where they can engage with a community of like-minded applicants aiming for infrastructure progress. The bootcamps, which require several hours of active participation each month, will last approximately 3-4 months. Participants will include mayors and municipal staff with job functions focused on finance, community engagement, and other relevant disciplines such as administrative and advisory affairs. A major emphasis will also be placed on helping communities understand federal priorities, such as equity and sustainability, and then incorporate these and other desired outcomes into submissions.

Dear Tamworth Village Residents and Businesses:

The Town of Tamworth is looking for 2 individuals to serve on the Tamworth Sewer Commission. The Sewer Commission has 3 members, who provide oversight of the village septic system, which serves the downtown area of Tamworth. The future of a vibrant downtown business and residential district depends, to a great extent, on a functioning septic system. Interested individuals need not be engineers or wastewater professionals, just civic minded and willing to learn. All adult residents of Tamworth are eligible to serve in this capacity.

The Commissioner meets once a month to perform the business needs of the Tamworth Sewer (Septic) System. This includes reviewing minutes, sign the account payable manifest, budget, user fees and all other items needed to run the system. Commissioners receive a \$700/year stipend. Interested individuals should contact the Select Board by December 13th at: admin@tamworthnh.org for more information.

The Sewer Commissioners are looking for a Secretary/Administrative Assistant. The Commissioner meets once a month. This position involves taking minutes, preparing items for the meeting, responding to correspondences and all additional duties assigned by the Commissioner's. This is a stipend position.
