## Town of Tamworth Facility Permit Stickers Application 2021

- 1. **All property owners/residents** must have a facility permit sticker by **April 30** every two (2) years. The Town Clerk will require proof of residency/property ownership.
- 2. **Renters:** Must provide either a notarized letter from the landlord OR a signed lease/rental agreement, along with a current utility bill showing your name and the physical address in Tamworth when initially establishing residency and/or to obtain a sticker by April 30 every two (2) years.
- 3. **Facilities Permit Stickers:** May be obtained at the Tamworth Town Clerk Office or by Mail in application or online at www.tamworthnh.org. One Replacement sticker will be given at no additional cost to those who can show proof of previous sticker (the old one, a portion of it, etc.) Without proof, the cost of the replacement sticker will be \$10.00 and reason must be given for why the original is no longer valid. Additional stickers, more than the two (2) given may be obtained at the cost of \$10.00 for each two (2) year sticker.
- Please Note: 1. Property owners/ residents/renters must have a permit sticker by April 30.

  Vehicles without a sticker after that date will not be able to use the Transfer Station and will be assessed a \$50 fine if found parked at Chocorua Lake Resident Only parking area or Bearcamp Pond Beach Area without a displayed sticker.
  - 2. Please display the Facility Permit Sticker in the <u>lower right-hand corner of the windshield on</u> <u>the passenger side.</u>
  - 3. It is the property owners' responsibility to keep Facilities Permit Sticker for two (2) years.
