#### **USDA Grant**:

The TSIC again presented the grant proposal to the Tamworth SelectBoard at their January 6, 2022, meeting. (Previous grant proposal was not approved by the SelectBoard by a 2-2 vote.) Lots of questions were asked and Becky Mason helped clarify the role SelectBoards play in overseeing grant money. This time the SelectBoard **approved** the application for the grant with the following vote:

Becky Mason: Yes, Melanie Streeter: Yes, Kelly Goodson: Yes, Emery Roberts: No, Aron Ricker: Absent (but previously voted yes).

SelectBoard members signed the application and Willie. F submitted it January 6<sup>th</sup>.

# Other Grant opportunities: (all info from websites: E. Farnum)

Maud, Willie and Gabrielle have been researching other available grants.

# ~Northern Border Regional Commission (NBRC)

(a Federal-State partnership for economic and community development within the most distressed counties of Maine, New Hampshire, Vermont, and New York).

Willie contacted NBRC. In his email, he requested that all the granting agencies work together to help fund our project. He outlined the proposed transfer station renovation and cost, gave information on the town profile, and explained that Tamworth has applied for the USDA grant to cover 35% cost.

Willie received an email back from NBRC suggesting he contact Benoit Lamontagne, NH Dept Business and Economic Affairs. It is possible that B. Lamontagne could help coordinate a meeting.

Willie will follow-up.

#### ~NH Charitable Foundation

(The vision of the Neil and Louise Tillotson Fund is "To serve as a catalyst for the region to move toward sustainable community and economic development in Coös County and surrounding communities in the United States and Canada.")

# ~US Department of Commerce Economic Development Administration

(Under the American Rescue Plan, EDA was allocated \$3 billion in supplemental funding to assist communities nationwide in their efforts to build back better by accelerating the economic

recovery from the coronavirus pandemic and building local economies that will be resilient to future economic shocks.)

#### ~NH the Beautiful

(New Hampshire communities are eligible to apply for funding to assist with the purchase of recycling equipment. Grant applications are considered on an individual basis and funding may be up to 20% of the purchase price of the equipment. While we will not help with the purchase of land, studies or buildings, we do help fund the purchase of balers, crushers, roll-off containers and other equipment that will help a community achieve higher diversion rates.)
