# **Mission statement:**

- To build a facility that will provide a safe working environment to employees and to the public using the facility.
- To explore options to reduce material in landfills, avoid costs and return revenue to the town.
- To upgrade/build the Tamworth Transfer Station Facility so that it has the capacity to store and bale recyclable products;

# **Letter to Surrounding Towns**

TSIC sent out a letter to surrounding towns to assess interest in regional solutions for recycling. Willie has received four responses. Ossipee, Madison and Moultonborough will stay with their existing facilities, and are not interested in combining with other towns.

Sandwich has scheduled a meeting to discuss the idea further.

Effingham and Freedom have not responded: Willie will follow up with a phone call.

# **Grant Information**

Gabrielle presented information on a 10/25 Zoom meeting with Paige Wilson from Lakes Region Planning Commission (LRPC) and USDA Rural Development Director Misty Sinsigalli.

There are two main grants that Tamworth could apply for.

## **Community Facilities Grant Loan:**

This grant is available to municipalities and can award up to \$50,000.

# **Community Disaster Grant Funds**

This grant will fund up to 35% of the total project cost.

Gabrielle noted that if the town applies for the whole project, they will get more funds than if the town decides to just phase in part of the project.

- ~Both grants have a December 15 deadline and allow a full year for design of the project.
- ~Plans would need an environmental review due to the National Environmental Policy Act (NEPA). More info is needed to determine how much this review would cost. Misty offered to have someone from her agency look at the proposed Tamworth project to help estimate the cost for the review. Misty is also willing to come to talk to the Tamworth SelectBoard.

#### Action:

TSIC will move forward with researching the grants and filling in applications for the Tamworth SelectBoard.

- Plan 1. End recycling: all material in MSW
- Plan 2. No change to the existing transfer station.
- Plan 3. Single stream
- Plan 4. Renovate the facility so that recycling and baling could occur.
- Plan 5. Regionalization

For a striking contrast to single-stream recycling, here's an article (with excellent video) from the latest edition of NRRA's "Full of Scrap" newsletter about Walpole NH's recycling program.

Walpole is a bit bigger than Tamworth (and a much wealthier town). but it might be helpful to take a field trip to see their program in action, or at least contact their recycling manager Ben Hoy with questions. Looks like they are producing bales of very clean, high quality recyclables - and limiting recycling of plastic to those types (PET and HDPE) that give a return. I wonder, though, about their hauling costs. The company they ship their plastic to (tabb packaging) is in Michigan! It sounds like an interesting company that's trying to do environmentally sound plastics recycling - but that's quite a haul. Here's the plastics info from the company's website:
